**19<sup>th</sup> Master Woodworkers Show Rules**

1. The Jury Submission and Application Fee is \$65.00 for the first three (3) submissions.
2. The Jury Submission and Application Fee is \$20.00 for each additional submission.
3. The Jury Submission and Application Fee is non-refundable.
4. Page 2 of this application must be completed. For additional pieces, submit additional page 2.
5. A minimum of one (1) and up to three (3) images of each submission must be attached to the Jury Submission and Application Form, for each submission. Images must be jpeg images not less than 1200 X 1200 pixels. All CDs must be labeled with the Artist or Woodworker's name and Submission A, B, C, D, E or F.
6. All submissions are subject to acceptance by the Jury panel and the East Tennessee Woodworkers Guild Board of Directors.
7. All submissions must be made primarily of wood.
8. All submissions that are juried into the Master Woodworker Show must remain on the Show floor for the duration of the Show.
9. Exhibiting Artists & Woodworkers may display a portfolio and /or business cards, with their display. The ETWG Board of Directors reserves the right to review and approve or disapprove all portfolios and business cards.
10. Exhibiting Artists & Woodworkers are requested to maximize their attendance on the Show floor, to communicate with the show attendees.
11. Any part of the submission which is not the work of the applicant (including finishing) must be acknowledged at the time of application and shall be given credit if the work is accepted to the show.
